REGULAR CITY COUNCIL MEETING:

Call to Order: called to order at 6:00 P.M. by Mayor C Loots.

MAYOR AND COUNCIL COMMENTS: Mayor Loots thanked B Thoma for all his work on researching and interviewing the potential affidavit operators.

COMMITTEE REPORTS:

PAC Public Relations Comm.: Tony Halligan, PAC Board president, addressed the Council and stated they are going to visit all City Councils in the district to extend the offer to partner together. He said PAC wants to ask each city how we can improve communication and work with each other. The school is central to quality-of-life issues for each community, and they want to understand how to best achieve our combined goals. They want to understand how to maximize our work together for our kids, our school, and our communities. The initial focus is on how they can utilize tax and joint grant monies to drive student outcomes, economic development, and overall quality of life and local career opportunities. Mayor Loots and Council member D DeVore asked some questions regarding the use of the school building and the bus barn. Mr. Halligan will share with the PAC Board the discussion regarding the Pomeroy Building, the PR updates and hopes to attend a few Council meetings a year moving forward.

Main St Building report: Lois Hessenius addressed the Council regarding her brother L Olsons buildings downtown. She discussed possible grants the City could look into for demolition. The Council stated with the extension given to Byron Stuart no action will be taken until they have an update at the April 8th meeting. B Hinners and K Hinners gave an update on the Hinners property downtown.

Affidavit Operator: Cody Rogers from Municipal Maintenance Services introduced himself to the Council as the City's affidavit operator. He reviewed with the Council the activities he has done and the training he will provide for B VanMeter.

Men's Club: Ben Olson discussed some event ideas for Homecoming this summer. He stated the Club would like to host a band downtown and apply for a liquor license.

Water/Sewer/Streets: B VanMeter gave an update on the activities for the maintenance department. The Council discussed the open maintenance position and the sidewalks downtown.

Park/Cemetery: The Council asked City Clerk Juilfs to book the foam party for Homecoming. A motion was made by D DeVore seconded by B Hinners to cut the ash tree into a vine/hummingbird carving and to have a cardinal carving placed at the directory. Nuisance Properties: The Council and Chief Gerdes discussed the nuisance property list for 2024 and the junk/unregistered vehicles.

Fire Dept.: D DeVore gave an update on activities for the Department.

City Hall: There was no update for the City website. The Council will have a public hearing on March 26th for the FY2025 budget.
