REGULAR CITY COUNCIL MEETING:

Call to Order: called to order at 6:07 P.M. by Mayor C Loots.

Roll Call: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Absent: none.

Pledge of Allegiance

MAYOR AND COUNCIL COMMENTS: The Council discussed mowing properties, the railroad trimming trees and gravel patching.

APPROVAL OF AGENDA: D DeVore made a motion, seconded by M Becker, to approve the agenda. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried.

CONSENT AGENDA: A motion was made by D DeVore seconded by B Thoma, to approve the consent agenda: financials, minutes, requests, reports and bill list. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried.

PUBLIC COMMENT: Teresa Hildreth Calhoun Co. Economic Development director introduced herself to the Council. She reviewed her work history and recent events with the County. She stated the CCED Board's priorities are existing business support, business attraction and recruitment, workforce development and community development.

COMMITTEE REPORTS:

Main St Building: K Lyon stated the committee has two options for relocation, but they would like to know how much time they have left in the building. The Council discussed the options and stated as soon as the north buildings become property of the City demolition would commence immediately. The Council stated they are seeking bids for demolition currently, so July 31st would be the last day in the building. A motion was made by C Charleston seconded by M Becker to allow Byron's Bar to use the Community building on Sundays from August 1st through October 31st to host his bands. Roll call: Ayes: B Hinners, C Charleston, D DeVore and M Becker. Nays: B Thoma. Motion Carried. A motion was made by B Thoma seconded by B Hinners to approve Byron's street dance and outdoor service for July 13, 2024. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried.

Catholic Church: Mary Clancy addressed the Council stated she has filed a recourse against the bishop's decision to de-church the Pomeroy Catholic Church. She hopes to stall the decision until

a new bishop is named in the Sioux City diocese so that the church could maybe reopen. She had a petition signed but would not share the signatures with the Council. She doesn't want to see the building demolished. She stated if the new bishop has the same views of the church and the recourse fails, she will not continue her fight against the City taking over ownership of the building. Water/Sewer/Streets: Jon and Harold Olson along with Adam Schoon discussed the standing water at the corner of N Seneca St and W Center St. A Schoon stated the ditch should be cleaned out and culverts installed to run water north. D Koyal stated the water will need to be pumped out so that repairs can be made to the intake and install a culvert. H Olson gave his permission for the City to tile 250 feet into his field after harvest and tie into his tile to relieve the water pond. Jon Olson also asked about the tile line south of the lagoon that his tile connects to and asked if the City would help pay to have the tile jetted out. A motion was made by D DeVore seconded by B Hinners to jet out the tile south of the lagoon and split the cost with Jon Olson. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried. D Koval gave a report on the department's activities including filling potholes, water plant update, lagoon discharge and crushing rock bid. Mayor Loots said she called for the tires to be picked up. A motion was made by B Thoma seconded by B Hinners to purchase up to 30 tons of two to three inch ballast for the driveway of the landfill. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried.

Park/Cemetery: A motion was made by M Becker seconded by D DeVore to place a post at the end of the stone of E Albrecht to prevent further damage from people turning the corner around her stone. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried. Mayor Loots stated the directory is being printed at Choice printing and new rubberized backs have been ordered to finish the update of the cemetery directory. The Council discussed the Memorial Day program and instructed City Clerk Juilfs to purchase an outdoor PA system. The Council discussed the painting of the bathrooms at the Shelter House. Mayor Loots asked the Council's permission to place a sculpture of a fallen soldier being carried to heaven by an angel called "Going Home" at the Veterans Park. She saw it at the Veteran's Park in Fort Dodge and wants to purchase a duplicate sculpture with Gordon's memorial money and her own funds if granted permission to place it in Pomeroy's Veterans Park. A motion was made by D DeVore seconded by M Becker to place the sculpture in Veteran's Park. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried.

Nuisance Properties: The Council discussed nuisance properties including grass, the dangerous downtown safe structure and properties for the attorney to send letters to.

Police Dept.: Chief Gerdes stated there were 49 calls for service and that she received complaints regarding dirt bikes in town. The Council also discussed abandoned properties.

Fire Dept.: D DeVore reviewed his meeting with Jeff Halder and Joe Kramer regarding the Fire department's use of only two bays at the bus barn. D DeVore voiced his concern with investing money into a building the City does not own.

Building Permit: A motion was made by B Hinners seconded by C Charleston to approve the building permit for 403 S Oswego St. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried. A motion was made by C Charleston seconded by D DeVore to approve the building permit for 205 E 3rd St. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried.

City Hall: The Council agreed to continue the office hours of Monday-Thursday 9am-3pm through the summer for City Hall. The Council discussed tornado shelter options in town. The copier agreement was tabled until a second bid can be obtained. A motion was made by D DeVore

seconded by C Charleston to approve Resolution #413 FY24 Budget Amendment. Roll call: Ayes: B Hinners, B Thoma, C Charleston, D DeVore and M Becker. Nays: None. Motion Carried. The Council will hold employee reviews on June 4th at 5:30P.M. **ADJOURNMENT:** 9:11 P.M.
